- **4.1** 2016/17 Annual Governance Statement for approval.
 - Annual Return Governance Statement prepared for approval by Clerk after Review of Internal Controls conducted by Cllr NH (03/17 - 4.5). Members agreed that the statement should be approved -proposed Cllr CF, seconded Cllr MF. All members in agreement. Document signed by Chairman for inclusion with Annual Return.
- **4.2** Quotations received for annual verge cutting contract.
 - Members advised of receipt of quotations for Verge cutting work throughout the parish for 2017. Two contractors only responded with one being significantly less costly than the other. Members agreed that the less costly option (from PR, JM & SR Houlston) should be offered the work for the coming season and proposal to offer the work to Houlstons made by Cllr CH, seconded Cllr NH. All members in agreement. Clerk to send offer of this work with instruction that it should not commence before 1st July.
- **4.3** Quotations received for parish grass-cutting contract.
 - Members advised of receipt of quotations for Grass-cutting work throughout the parish for 2017. Two contractors responded initially one was subsequently withdrawn prior to this meeting - leaving only one quotation to consider. Members were disappointed that the alternative quotation was withdrawn as the quotation seemed to offer equally good value to that which remained in contention. Members agreed that the withdrawn quote could not be considered under these circumstances and consequently the remaining tender (from JJ Harrison Ltd) should be accepted. Proposal to offer the work to JJ Harrison Ltd made by Cllr NH, seconded Cllr CF. All members in agreement. Clerk to send offer of this work accordingly.
- **4.4**** Membership subs due for YLCA/NALC.
 - Members advised of renewal subs due for membership with YLCA/NALC for 2017.
 Proposal to continue membership made by Cllr CF, seconded Cllr RN. All members in agreement. Cheque 100053 issued in payment.

 - Members advised of figures to be returned with the Model Agreement Expenditure statement for 2016/17. Figures show the full expenditure incurred in each category for the relevant year, which greatly exceeds the monies received from SBC under this agreement. - **5.1.1** Public Toilets within Glaisdale Parish information received.
 - Members advised by D/Cllr CP of developments in relation to the provision, by SBC, of
 public toilet facilities at Lealholm. SBC officers have decided that they are unable to
 continue incurring expenditure for the running of this facility in Lealholm (this is one
 among several throughout the borough which have been singled out for closure) and have
 made recommendations to Cabinet that this facility be closed. Cllr CP indicated that once
 this recommendation is approved by Cabinet then the facility will be closed permanently.
 (This would normally happen within six weeks but the imminent General Election may
 have delayed this process temporarily.)
 - As previously discussed by members on several occasions in the past, the option of the
 parish council taking on these toilets has been considered unaffordable and such an
 option has been dismissed. Members do however consider that the provision of these

facilities is essential in a tourist orientated area such as Lealholm. The potential for replacement of this dilapidated facility at Lealholm through its inclusion as a s106 requirement for the developers of the proposed affordable housing project nearby would mean that toilet facilities could be maintained into the future, (albeit with a possible interim period without any facility at all!) This stage in the housing negotiations has not yet been reached however and is currently only a possible answer to this problem.

- There are many facets of the affordable housing project yet to be agreed and members decided that these outcomes should be decided before any way forward on the toilets could be decided upon.
