## **MINUTES OF GLAISDALE PARISH COUNCIL MEETING** held at The Robinson Institute, Glaisdale, on Thursday 16<sup>th</sup> March 2023.

1. **MINUTES OF PREVIOUS MEETING :** Presented, agreed and signed as a true record
2. **MATTERS ARISING FROM THE MINUTES**
  - 2.1 February 2023 Police Reports.
    - **Noted - PCSO Lewis advised members of recent activity (Published report not received in time for this meeting)**
  - 2.2 War Memorial – Glaisdale – update on committee/wreath support.
    - **Members discussed the formation of a committee from the number of members of the public who have come forward and expressed an interest. Cllr Allanson advised that those interested did not wish to be involved with any upkeep of the monument but just to be concerned with the organisation and implementation of the annual remembrance service. Members agreed that any committee formed should restrict themselves to this activity only and that maintenance and upkeep of the memorial structure should remain with Historic England.**
    - **The proposal to erect a small rail to act as a permanent support for Wreaths laid during the remembrance services was discussed and members were generally in favour of installing a design similar to that proposed by Godbolds Blacksmiths, for which GPC has a recent quotation. Cllr Norris queried whether the parish council should be spending public money on this proposal but C/Cllr Pearson indicated that his locality budget could be used to support about 80% of the costs with the parish council funding the remainder. Members were supportive of this approach and further enquiries are to be made of Danby Court Leet and NY Highways to see if any permissions are required.**
  - 2.3 Security camera use – update on legal advice received.
    - **Members advised of advice received from YLCA regarding the validity of a parish or town council using directed or covert intelligence gathering under the RIPA provisions. The RIPA (Regulation of Investigatory Powers Act 2000) legislation dictates which local authorities and other public bodies are allowed to engage in these activities under Part 1, sections 28 and 29 of the legislation. Parish and Town Councils are NOT listed within the legislation and so are not legally permitted to undertake such activity.**
    - **Members accepted this but then considered how the funding available could be utilised to provide the items necessary to allow other bodies (such as local Rural Watch**

organisations) to assist their activities. PCSO Lewis suggested that this solution would not put the council in breach of current legislation and that the outcome would be similar and allow any evidence gathered to be utilised by the police in court if necessary.

- Members agreed to allow local Rural Watch organisations to apply to the council for a grant of camera equipment for use in their crime prevention role.  
Clerk to process the funding opportunity and arrange for the purchase of camera equipment in due course.
