 - **Having heard of the circumstances which could potentially see the closure and loss of this much valued facility at Lealholm members were keen to be as helpful as possible in taking forward these plans which would benefit not only the Cricket and Football teams at Lealholm but also other community groups who may wish to use the pavilion for their events into the future. Proposal to donate the sum of £250 made by Cllr RN, seconded Cllr MH. All members in agreement. Clerk to make payment via bank transfer once bank details made available by Cllr TC.**
