- **2.1** July & August (August/September) 2023 Police Reports

- Anglers Quarters. Also that the roof ridge line did not accord with that of the terrace that is Anglers Quarters.
- This current submission addresses the ridge line issue but not the access issues and the building construction is still significantly different to the Anglers Quarters properties.
 Members are of the opinion that the property should be stone built with a slated roof to be in keeping with the local street scene.
- Members continue to object to this application in its present form.
