7.1 Lealholm Parking Issues.

Members have raised two separate parking issues at Lealholm.

- **Vehicle parking at roadside between the school and the nearby council car park. This vehicle is causing a severe hazard to traffic turning left onto C1 highway at the junction near to the war memorial.**
- **Vehicle parking on bend in C1 highway near to Island Cottage. This vehicle sits in a blind spot to vehicles coming from Houlsyke who have to move to the opposite side of the carriageway to pass and who are not visible to traffic coming the other way.**
