### 5. CORRESPONDENCE

# 5.1 Action / Reply

- **5.1.1** Parliamentary enquiry and call for evidence on restriction of recreational motor vehicles (eg 4x4s, quads & motorcycles) re their use on/in Green Lanes, National Parks and AONB's. This in response to the Glover Landscapes Review.
  - Members advised that this report was received only one week ago with a response deadline of 20<sup>th</sup> July. This council had responded to the 2022 review and the results of that consultation revealed that, like this council, 76% of parish and town councils would like to see legislation brought in to curb the use of motor vehicles on green lanes.
  - This latest consultation asks for evidence to be submitted to support the introduction of such legislation. This evidence should take the form of letters from affected individuals and landowners, images showing the damage caused by off road vehicles, as well as how such use deters other users from enjoying these lanes and byways.
  - Members thought that the deadline for producing such evidence was ridiculously inadequate and so this council should inform the parliamentary body that they should rely upon the evidence provided to the original consultation in 2022.
- **5.1.2** Council IT Policy requirement for Town & Parish Councils.
  - Members advised that Clerk is compiling a new IT policy for GPC which will be ready for approval and adoption at the September meeting. The new policy will introduce a change to existing practice in relation to use of email accounts when responding to parishioner queries. Clerk to set up new members email facilities in time for September.
